You Need To Provide:



Passport

You must provide your actual signed passport, including one copy of the personal information page of your passport. Your passport must:

- Be valid for six months beyond the length of your requested visa (for example, if you are requesting a 12 month visa your passport must be valid for 18 months)
- Have at least one blank visa page (amendments and endorsement pages cannot be used to fulfill this requirement)
- If requesting multiple entries, the passport must contain at least two blank facing visa pages, there can be no stamps or amendment endorsement type on the pages
- Not be frayed, torn, separating, or altered in any other way

If your passport does not meet these requirements, please contact VisaCentral at (866) 788-1100 for further details.



Photographs

You must provide one color, passport-type photograph. The photograph must:

- Be printed on photo paper
- Be two inches by two inches
- Have a white background
- Have been taken within the last six months

Chinese Born Citizens

If you were born in China:

- You must write your name in Chinese characters for question 1.3 on the visa application form
- If you have been previously issued a China visa in your current or expired passport you must submit a copy of that visa
- If you have never been issued a China visa you must submit your original Chinese passport and birth certificate showing your name in Chinese characters
- If you are a minor who was adopted from China you must also include your original adoption papers and a copy of them as well
- If applicable, include a copy of your naturalization papers and U.S. birth certificate.

Hong Kong or Macau Travel

Visiting Hong Kong or Macau is considered leaving China. You must obtain a multiple entry visa if you leave Mainland China to visit Hong Kong and Macau with the intention to re-enter the mainland before finally departing from China.

Expedited Processing

The Chinese Embassy requires you to submit a travel itinerary if you choose to expedite your visa. Your itinerary must show proof of *direct departure to mainland China* within 3 business days if you choose "2-3" day processing on your China visa application.

Children Under 18 Years Old

All minors traveling to China must provide a copy of their birth certificate in addition to the other visa requirements specified in these instructions. Other conditions apply:

- * The parents of the minor must provide a copy of each parent's US Passport
 - * If the parents are not U.S. citizens, they must provide a copy of their U.S. Status
 - * If the parents are not accompanying the minor on the trip, both parents must provide a notarized authorization letter that states the child has permission to travel
 - * On page 4 of the application, both parents must complete and sign sections 6 and 7. Above the signature at section 6 the parents must write the minor's name as it appears on the passport.

Urgent Applications

For urgent visa applications which carry a tight deadline, we offer a Pre-Check service to save applicants valuable time. Once you have collected the required documents for your visa application and completed the visa application form, simply scan these items and email them over to our team. Cruise Passengers

Cruise ship passengers: You must list the city where your ship docks in China in the Chinese address section of the application form.

Processing Times:

Please submit your materials to VisaCentral no earlier than 90 days prior to the arrival in the first destination requiring a visa, but no later than 21 business days prior to the date you need your passport returned to you. Every effort will be made to submit your completed applications to the consulate on the day received, if it reaches our office by 8.00 a.m. or earlier. A \$30 fee applies to orders submitted on the same day that we receive your application. If you are ordering a passport in addition to your visa, please remember that passports must be processed separately from visas and will require additional processing time to be taken.

Guide to Completing Your China Visa Application Form

The following instructions will assist you in successfully completing your China Visa Application Form. Your China Visa Application Form must have an answer in all fields in order to be accepted by the Consulate of China. **Read the field labels carefully to ensure that you understand the information that is being requested.** Each informational field is labeled in both Chinese and English to accommodate the needs of the consulate.

China Visa Application Form Instructions

The following tips will help ensure the accuracy of your answers when completing your China visa application.

Question Number:

Instructions

- 1.1:** List your last name (surname) and first name (given name) as they appear in your passport
- 1.3:** Complete only if applicable (otherwise write "N/A")
- 1.4:** Provide your maiden name or other names you are, or have been, known by if applicable (otherwise write "N/A")
- 1.5:** Complete only if applicable (otherwise write "N/A")
- 1.11:** You may use your Driver's License number or the number of another state-issued i.d. to complete this field
- 1.13:** If you are retired, check "other" and write in "retired", and list your previous profession, otherwise provide your current profession or occupation and business telephone number
- 1.14-1.18:** This information appears at the beginning of your passport
- 2.1:** Check "Tourism"
- 2.2:** Check "one entry" or "two entries" based on your trip itinerary (Note: You will need a double or multiple entry visa if you intend to leave mainland China to visit Hong Kong or Macao)
- 2.3:** You must indicate the date that you will enter China
- 2.4:** You must indicate the greatest number of consecutive days that you will be staying in China
- 2.5:** Provide the address of the hotel with which you will be staying during your visit. If on a cruise, list the port of entry in China and indicate "Onboard Ship" as your place of stay
- 2.6:** Check the appropriate box that applies to you
- 2.7:** Provide the name of your medical insurance provider along with the your insurance plan number if you are insured
- 2.8:** Write the specific name of your prepaid cruise or tour along with the name of the cruise or tour company that is conducting your trip
- 3.6:** Include the names of your immediate family members
- 4.2:** List any countries that you have visited within the past year and provide your reason, such as business or tourism, for traveling there
- 4.3-4.7:** Check the appropriate boxes that apply to you; if you have ever been refused a Chinese visa or entry into China, please contact us for assistance


